General Information

Food and Drinks

Organizers, or their guests, must not enter the Hotel with any food acquired elsewhere, without prior written authorization of the Hotel Management.

Use of Restricted Areas

Any fixation to pavements, walls, ceilings and columns, using nails, screws, tacks, adhesive tape or any other means for attaching objects to a ceiling or wall, as well as the removal of existing decorative objects, is strictly prohibited. The repair of any damages caused to the Hotel facilities or equipment, attributable to a person present in the event, shall be the Client's sole and exclusive responsibility, whereas the Hotel is authorized to charge for such damages in the invoice of the event or after the event takes place.

Hotel Advertisement and Image

All advertising and/or promotion of in-house events, as well as the use of the Hotel name and logo, must be reported and duly authorized by the Hotel Management.

Losses

The Hotel shall take no responsibility for any lost goods left by the organizers or their guests in the facilities, whether before, during or after the event.

Security

The presence of security guards before/during events must be reported and approved by the Hotel Management.

Orders, Packages and Printed Materials

The Hotel may receive several materials for the event, on behalf of those responsible for the same. These materials must be properly labelled and identified, including the name of the event, the organizer's contact details, the name of the Hotel representative and the date of the event. Incoming materials to be paid against delivery will not be received. The collection of any surplus materials should be done on the last day of the event.

Booking Conditions

- 1) Groups of 10 persons (adults) minimum.
- 2) The approximate number of persons participating in the events must be reported at the time of booking, with an advance payment of 30% of the total value for confirmation.
- 3) The final number of participants and the remaining 70% of the total value must be confirmed no later than 2 business days prior to the date of the event. The aforementioned number shall be the final and definitive number for invoicing purposes and corresponding payment. If the number of participants exceeds the originally confirmed, invoicing shall be adjusted accordingly.
- 4) In the event of a 50% (or more) reduction of persons from the time of booking to final confirmation, Hotel Faro may charge a penalty rate corresponding to 50% of the value of the cancelled meals.
- 5) After having reported the final number of guests, any cancellations or non-attendances shall be charged in full.
